STANDARD AGREEMENT

This agreement shall be in force from the date signed and for all visits thereafter to Pooches Paradise LLC, hereafter referred to as 'PP LLC'.

I, _____, hereby certify that my dog(s): _____ is/are in good health and have not been ill with any communicable diseases in the last 30 days; and that my dog(s) has/have current vaccinations for rabies, distemper, parvovirus, hepatitis (adenovirus) and a semi-annual (6 month) bordetella. Dogs arriving with fleas and/or ticks may be treated with Advantage™ or other flea control product at PP LLC's discretion, at my expense. I further certify that my dog(s) has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog, except as disclosed under the Client Information Form. I give authorization to PP LLC to speak with my veterinarian and/or their staff to confirm my dog(s) vaccination status, date of surgical alteration, and medical history.

I have read and understand the following:

- 1) PP LLC is an open play environment and because of this there are inherent risks, which even when closely monitored, may result in the following: i) transfer of communicable illness such as, but not limited to, bordetella virus ("kennel cough"), and ii) superficial injuries such as, but not limited to, broken nails, sore pads, minor abrasions and/or cuts.
- 2) PP LLC and their staff shall not be liable for any injury or damage to any person or persons, animals, or to any property, however caused, which result from the training, behavior, care or grooming of my pet, as well as from any negligence on the part of any other pet owner attending PP LLC. I further agree that PP LLC shall not be liable for any costs, attorney's fees or expenses incurred in connection with any claim, action or proceeding occurring as a result of my pet's participation at PP LLC.
- 3) PP LLC reserves the right to administer aid and/or use any available veterinarian for my pet should the need arise, whether or not PP LLC can reach me or my emergency contact. I assume full financial responsibility for any and all veterinary expenses incurred, in addition to other fees incurred for services provided at or by PP LLC.
- 4) I agree to pay the rate for services in effect on the date my dog(s) attend(s) PP LLC. Prices are subject to change at any time. No dog will be released until all charges are paid in full. Cancellation fees may be applied for reservations cancelled less than 24 hours prior to a scheduled reservation.
- 5) I am solely responsible for any harm and/or damage caused by my dog(s) to persons, property or other pets, while my dog(s) is/are attending PP LLC. Costs for repairs to property will be my sole responsibility. No aggression, by dogs or humans, will be tolerated and are cause for immediate dismissal. PP LLC reserves the right to refuse services or admittance to any dog.
- 6) I understand that the public day care hours of operation are from 7 a.m. to 7 p.m. Monday through Friday. Weekend daycare and boarding drop off hours are between 8 a.m and 9 a.m and pick up hours are between 3 p.m and 5p.m. Holiday operating hours typically differ from our normal operating hours, these can be obtained on our website. I agree to pay the \$15.00 convenience fee for each dog picked up after the operating hours. Dogs not picked up by 7:15 p.m. will be subject to an additional boarding charge and will be released the next business day, unless arrangements with PP LLC are made to the contrary. Pooches hours and convenience fee prices are subject to change at any time.
- 7) Should I or my pre-approved agent fail to contact PP LLC within 48 hours of the arranged pick up time; my pet will be considered to be abandoned. Any expenses incurred for the transport, overnight care, and/or placement or adoption of said pet shall be paid by me in addition to other fees incurred for services provided by, at, or through PP LLC. I hereby grant a lien on said pet for any and all unpaid charges resulting from services provided by, at, or through PP LLC.
- 8) I agree that my pet(s) may be videotaped, photographed, and/or recorded. PP LLC shall retain the exclusive rights to the results and all proceeds of such tapings, photograph, and recordings with the rights throughout the world, an unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner.
